**STUDENT USE OF TECHNOLOGY**

I acknowledge Denair Unified School District offers student access to the Internet and other electronic networks through the district network (as defined in the Student Use of Technology-BP 6163.4). Increasingly, the Internet is the vehicle we use to deliver core curriculum materials. We believe that the educational advantages afforded by the rich, digital resources available through the district network and the Internet, outweigh the disadvantages. All Internet access through the district network is filtered for content as per the Children's Internet Protection Act (CIPA).

You may choose to opt out of Internet access for your student. You may request an Opt-Out Form from your student's school office designating that your student NOT be allowed to access locations on the Internet, other than core curriculum and assessments, through the Denair Unified School District's network. This opt-out will remain in effect for the school year in which it is signed. If you wish to renew this for future years, you will need to sign a new form at the beginning of each subsequent school year.

**PUBLISHING RIGHTS**

I understand there are times during the year when photographs, audio-visual recordings of students, or their work, may be used in school/district publications or on the school/district web site. When possible, we will alert parents in advance, but this is not always possible.

You may choose to opt out of allowing your student to appear in photos or other recordings taken by or on behalf of the Denair Unified School District. You may request an Opt-Out Form from your student's school office designating that your student NOT appear in school/district publications or on the school/district web site. This opt-out will remain in effect for the school year in which it is signed. If you wish to renew this for future years, you will need to sign a new form at the beginning of each subsequent school year.

**RELEASE OF STUDENT INFORMATION**

The District does not release information or records concerning a child to noneducational organizations or individuals without parent consent except by court order, receipt of a lawfully issued subpoena, or when otherwise allowed by law. The following categories of directory information may be made available to various persons, agencies or institutions unless the parent or guardian notifies the District in writing not to release such information:

Name, address, telephone, date of birth, e-mail address, student ID, username, gender, ethnicity, home language, major field of study, participation in officially recognized activities and sports, weight and height of members of athletic teams, dates of attendance, diplomas and awards received, and most recent previous educational institution attended. [EC 49060 et seq., 49073; 20 USC 1232g; 34 CFR 99.7] In accordance with state and federal law, the District may also make available photographs, videos, and class rosters. You may request an **Opt-Out Form** from your student's school office designating that your student's information NOT be made available to outside agencies. This opt-out will remain in effect for the school year in which it is signed.
