Transitional Kindergarten and Kindergarten Application and Registration Information

It is time to apply and register for kindergarten for the 2021-2022 school year! If interested in transitional kindergarten or kindergarten for the 2021-2022 school year, please go to denair.schoolmint.net to fill out an application.

- The initial application period will be open from January 21, 2021 through February 11, 2021.
- From February 16, 2021 through February 19, 2021 we will send offers to register for the 2021-2022 school year.
- Upon receiving an offer to register, please complete the registration process between February 22, 2021 through March 31, 2021.
- During registration families need to complete all online forms and upload all required documentation. If registering for the dual language immersion program, the additional dual language immersion program requirements listed below must also be completed. If all registration requirements are not completed by March 31, 2021 the offer to register at DECA could be rescinded based on availability of spots.

Our programs fill up quickly, so we encourage you to have all the necessary requirements completed by the dates listed. Not completing all requirements of registration may result in the registration offer being rescinded and/or not being able to enroll in your preferred program.

The application process will be closed from February 16, 2021 through February 19, 2021 and will reopen February 22, 2021 based on availability of spots.

Our online application and registration system can be accessed on a computer laptop, tablet, and phone.

Required Documentation to Upload During Registration Process:

1. Child's **county** birth certificate
2. Proof of residence – **must be a recent utility bill in the parent/guardian's name and must show the property address**
3. Current immunization records *(By California state law, students must be immunization compliant in order to enroll in school.)*

Required Online Forms During Registration Process:

1. Program Preference Form
2. Annual Verification Form
3. Home Language Survey
4. Student Information Ethnicity Form

5. Student Health Inventory
6. Oral Health Assessment Form
7. DLI Parent Understanding and Commitment Form (required only if registering for the dual language immersion program)

Additional Requirements for Registration in the Dual Language Immersion Program

1. Attend **one** of the following mandatory parent orientation meetings via zoom. Zoom information (meeting ID and passcode) can be obtained by calling the school office.
 - a. Dates are as follows: 2/3/21 at 8:30 a.m., 2/8/21 at 1:00 p.m., 2/10/21 at 5:00 p.m., 2/18/21 at 11:00 a.m., 2/23/21 at 4:00 p.m., 3/8/21 at 10:00 a.m., 4/15/21 at 3:00 p.m., 5/4/21 at 5:00 p.m., 7/30/31 at 12:00 p.m.
2. Complete and submit a DLI Parent Understanding and Commitment Form **AFTER** attending one of the mandatory parent orientation meetings.

Important Note:

The first day of school (2021-2022 school year calendar will be published soon on the Denair Unified School District website) is Kindergarten Round Up. During this time students will meet the teacher and tour the classroom. Parents and guardians will meet the teacher, tour the classroom, turn in the kindergarten questionnaire, drop off classroom supplies from a supply list sent home in July/August, and ask any questions they may have.

Students and parents/guardians will come together at the designated time below according to the beginning letter of their **last name**. **Students and parents/guardians will leave Round Up together** after they have met the teacher and completed the kindergarten questionnaire.

Last names beginning with A-M will come from 8:00 a.m.-9:00 a.m.

Last names beginning with N-Z will come from 9:00 a.m.-10:00 a.m.

****Kindergarten Round up will be held as COVID conditions allow. If COVID conditions do not allow for this event, new plans/information will be provided to parents prior to the first day of school.****
